- 2. YOU agree to and shall perform the following (if/as necessary):
 - If YOU test positive for COVID-19, YOU will inform US within twenty-four (24) hours after learning so;

regularly washing hands and wearing masks in public Initial:

- If YOU test positive for COVID-19 or experience, display, or have Symptoms as described above, YOU will cease attendance from any physical class or session, until cleared by a physician and US, or YOU take a COVID-19 test and the result is negative;
- If a member of YOUR household tests positive for COVID-19, YOU will not attend a physical class or session for a period no less than fourteen (14) days or until YOU take a COVID-19 test and the result is negative;

- If YOU travel internationally or attend any event of 20 people or greater, YOU will cease from attending any physical class or session for a period no less than fourteen (14) days or until YOU take a COVID-19 test and the result is negative;
- 3. YOU agree that WE may contact YOU as follows:
 - a. To inform YOU that someone who trained on the same day as YOU tested positive for COVID-19;
 - b. To inform YOU that someone who trained in the same group as YOU tested positive for COVID-19;
 - c. To inform YOU that a class or session has changed, been modified or has been cancelled:
 - d. To inform YOU of class or session availability
- 4. YOU further agree to the following:
 - a. YOU are personally responsible for YOUR safety and actions while attending any class or session;
 - b. YOU will comply with all policies and rules;
 - c. YOU, for yourself and on behalf of your family, spouse, estate and heirs forever release, waive, discharge, and covenant not to sue the Released Parties (Karate 4 Kids USA, its officers, directors, owners, members, employees, agents) from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage or injury (including death) that may be sustained by ME related to COVID-19, whether caused by negligence of Released Parties or third parties using the facility and equipment;

YOU agree to indemnify, defend and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities (including attorneys fees and costs) arising either directly or indirectly from or related to any and all claims made against any of the Released Parties due to use of the facility, equipment or COVID-19;
